Q: Can you change the distance that cars are allowed to park from corners? Changing this may provide a few extra parking spaces.

A: We are looking to change this in the city as these regulations are set by the state. We have been working with our Traffic and Engineering team on doing this. Before we move forward, we need to have a meeting with the Fire Department. They have some concerns about changing the distance that cars allowed to park from corners, but we are actively working with them to see what we can do.

Q: The intersections of Brunswick/1st Street and Monmouth/1st Street are very dangerous. Speed bumps could help.

A: There was a petition submitted for a speed hump on Brunswick between 1st and 2nd which is being reviewed by Traffic and Engineering

Q: Would like a "Don't Block the Box" sign and grid on 3rd and Newark.

A: We have sent this request to our Traffic and Engineering team. We are waiting for their review but will make sure to follow up on this.

Q: We would like street paving on 1st, 2nd, and 3rd Street on our side of Brunswick.

A: There is currently road paving scheduled for 1st from Brunswick St to Merseles St. We have sent a request for road paving for 2nd and 3rd.

Q: We would like a stop sign at Division and 6th Street.

A: We have sent this request to our Traffic and Engineering team. We are waiting for their review but will make sure to follow up on this.
